## What are The Friends of the Republic Library Doing Now?

Besides fun, educational projects and programs for young and old, we are focusing on a new building. Land has been donated, and we have funding for a preliminary concept!

FORL does not anticipate using new tax dollars or a levy for this facility. NCW Libraries, a 5 county system with 30 Libraries, has funding set aside for furnishing our new library; there are endowed funds set aside; and community-focused grants are available to us. We are currently working with the Department of Commerce, Innovia Foundation, community partners, and our Legislative representatives to continue making this a reality. The library will be potentially co-located with (but separate from) a new Community Hall, City Hall, and other needed facilities as defined by the community during the design process, to meet as many needs as possible at this location.

This proposed expansion meets many of the needs of our community. The long term effect will help to create and maintain an educated and well-informed work force, and will have lasting effects in an area that craves revitalization. We have high hopes knowing that this major library overhaul can, and will, help our community. The key to lifting citizens up in our remote area relies upon enjoying educational, economic, and cultural services for families, youth, and seniors.

In addition to library materials, we envision:

- $\Rightarrow$  an all-season, natural play space for kids
- $\Rightarrow$  a place for teens to learn constructively
- $\Rightarrow$  a place for seniors citizens to gather
- $\Rightarrow$  a soundproof room and quiet space
- $\Rightarrow$  an office and break room dedicated for staff
- $\Rightarrow$  a functional, flexible community-use area with a stage
- $\Rightarrow$  accessible STEM and other hands-on programming space
- $\Rightarrow$  a commercial kitchen for events, meetings, and demonstrations
- $\Rightarrow$  a protected outdoor area for play
- $\Rightarrow$  ample parking
- $\Rightarrow$  a building that our community will be proud of
